## *Why use the Binance Smart Chain?*

As of the latest reports, the Binance Smart Chain has surpassed the Ethereum chain in terms of daily transaction volumes. While Ethereum currently handles around 1.2 million daily transactions, the Binance Smart Chain is processing over 1.6 million transactions per day. This is a significant increase from just 300,000 transactions in January of this year. Notably, the total value of assets held in the Binance Smart Chain has skyrocketed from US\$1.3 billion to US\$5.7 billion in just under 10 days.

The Binance Smart Chain offers several advantages over the Ethereum chain. Transactions on the Binance Smart Chain are significantly cheaper, costing around US\$0.01, compared to the high gas fees on the Ethereum chain, which can cost more than US\$150 per transaction. Additionally, transactions on the Binance Smart Chain are confirmed in just three seconds, whereas Ethereum transactions can take three or more minutes to confirm.

For investors, the lower transaction costs and faster confirmation times on the Binance Smart Chain can translate to greater profitability. Investing in BEP-20 tokens on the Binance Smart Chain requires only 1-2% of the investment to be profitable, compared to ERC-20 tokens on the Ethereum chain, which may require a 50% price increase just to break even due to high gas fees and exchange fees.

Overall, the Binance Smart Chain's impressive growth and superior transaction speed and cost make it a promising alternative for those seeking to invest in blockchain technology.

## The AIPad Tiered System

### *Leaderboard: Allocation Round*

Token holders will be placed in different tiers based on their token holding amount and period of token holding. The top holders in the leaderboard receive guaranteed allocations in the token sales.

Once all the tokens have been sold, the IDO will come to a close, but our work doesn't end there. We're committed to continuously improving our token sale process and gathering valuable data and feedback to inform future iterations of the IDO structure. As a community-driven project, we're open to hearing your thoughts and ideas, and will even consider DAO proposals to enhance the overall user experience.

# Security Protocol

Security is of utmost importance to AIPad. We implement a mix of custodial and non-custodial wallet solutions, depending on service offerings. When custody is required for specific services, we will leverage an industry-grade security solution that dispatches the strongest encryption technology available to prevent the possibility of malicious attacks.

Given our emphasis on security, we will primarily focus on offering non-custodial services for initial staking through Delegated Proof of Stake (DPoS) tokens. By doing this, we will be able to greatly mitigate security risks as we will not directly handle digital assets. Tokens that are offered as Proof of Stake (PoS) will be maintained through industry-leading security protocols.

## The \$AIPAD Token

In order to operate the launch pad, offer staking rewards, conduct competitions, and execute marketing initiatives, AIPad launched a BEP-20 token called \$AIPAD.

\$AIPAD will be the native token for all solutions related to AIPad. The utility and the usage of \$AIPAD tokens corresponds to the amenities of the technology and tokenization. Users will need to stake this token in order to participate in an IDO.

The token is also designed to be a utility coin and will be used to incentivize holders to adopt the protocol. \$AIPAD token will therefore be the main trading base for trading pairs as well as for payment of relevant fees.

\$AIPAD funding is split into 3 rounds: a seed round, a private round, and a public round. The seed round has already been filled, allowing us the development and marketing budget to take us to a launching point. The maximum funding amount per wallet in the public round is determined by the tier system. The higher the tier for each of the public round launchpads, the higher the allocation.
